#### I, Kristina Ross, declare as follows:

- 1. I am an attorney duly admitted to practice before this Court. I am an attorney with Manning & Kass, Ellrod, Ramirez, Trester LLP, attorneys of record for Plaintiff WILLIAM JAMES MITCHELL. I have personal knowledge of the facts set forth herein, and if called as a witness, I could and would competently testify thereto. I make this declaration in support of Plaintiff's Opposition to Defendant's Motion to Compel Further Responses to Requests for Production of Documents, Set III, and Request for Terminating Sanctions and Monetary Sanctions.
- 2. On June 9, 2023, Plaintiff served responses to Requests for Production of Documents, Set Three.
- 3. As to Request No. 231, Plaintiff responded that he was unable to comply because the requested items are no longer in his possession due to the fact that he donated all of the awards from his video game career to the International Videogame Hall of Fame in or about 2010.
- 4. As to Requests Nos. 232 and 240, which are not mentioned in Defendant's Motion, Plaintiff responded that he was unable to comply because the requested items, if they ever existed no longer exist, or are no longer in his possession due to the length of time that has passed since the photographs may have been taken. Plaintiff also objected on the ground that the requested documents were equally available, as there are photographs online, and Plaintiff has no obligation to scour the internet for such equally available information.
- 5. As to Requests Nos. 251 and 293, Plaintiff objected to these requests on the ground that production would violate the confidentiality of the settlement agreement, among other objections.
- 6. As to Request No. 265, Defendant requested all documents related to all communications between Plaintiff and his son since January 1, 2020 despite being advised that Plaintiff's son is an independent contractor working for Manning & Kass as a law clerk and all communications would therefore be protected under attorney-client privilege. Further, Plaintiff objected on the grounds that this request had no limitation to it being related to the claims made in Plaintiff's lawsuit, making the request overbroad, burdensome, oppressive, and harassing.

- 7. On June 26, 2023, I attended the deposition of Cross-Defendant Walter Day. During the deposition, a photograph of Plaintiff's awards, including Namco plaques, was discussed. At that time, I was forwarded an email in which John Grunwald sent Plaintiff a picture of the awards previously donated to the International Video Game Hall of Fame and Mr. Grunwald stated, "It appears the lost has been found." See Defendant's Compendium of Evidence, Ex. 18.
- 8. On June 26, 2023, Defendant's counsel requested said photograph prior to the deposition of Jerry Byrum, the current principal of the International Video Game Hall of Fame, which was occurring after Mr. Day's deposition. In order to send it to him quickly, and while under no duty to do so, I saved the image as "IVGHOF." During Mr. Byrum's deposition, Defendant's counsel questioned me on the naming and where I received the photograph. I advised I received it that day from Plaintiff, with an email from Mr. Grunwald. I was working off the little information available to me at the time in an attempt to be cooperative with Defendant's counsel. See Defendant's Ex.11 and 18.
- 9. On June 26, 2023, Mr. Byrum testified that he did not look for the awards as requested in Defendant's subpoena and that he does not recall Plaintiff asking him to find the awards or send them to him. Mr. Byrum also testified that he did not personally receive awards from Plaintiff; however, he further stated that he was not a part of the International Video Game Hall of Fame in 2010 when Plaintiff contends he donated the awards and that sometime after 2019 he personally gained control over all the items that belonged to the International Video Game Hall of Fame, but the items were scattered among multiple storage areas along with his personal and business items. See Defendant's Exhibit 3, 11:23-12:19 and 14:1-15; Attached hereto as Exhibit A are true and correct portions of Mr. Byrum's deposition, see 35:17-38:3.
- 10. On July 5, 2023, Defendant's counsel requested a meet and confer. I had a telephonic meet and confer with Defendant's counsel and again repeated the information available to me and my understanding regarding the plaques, which was that they were found by Mr. Grunwald on the weekend of June 23, 2023 while at an event at the Bridgeview Center. I also noted that Mr. Ellrod and I were engaged in a bench trial, but I could have someone else appear at the ex parte if need be; however, Defendant's counsel later emailed that we could resolve the issue in an Informal Discovery

Conference and asked for an extension on any potential motion to compel. On July 6, 2023, I reiterated my understanding based upon the information I had at that time and granted Defendant the extension to allow for an Informal Discovery Conference. See Defendant's Ex. 14.

- 11. On or about July 20, 2023, I was advised that Plaintiff's plaques were found by Isiah Triforce Johnson on June 23, 2023 in the storage room at Jerry Byrum's arcade while looking for his own memorabilia that he donated to International Video Game Hall of Fame. Mr. Johnson then brought the awards to the Bridgeview Center, where he and Mr. Grunwald looked at them and Mr. Johnson took photographs of them. Mr. Johnson then took the awards, intending to return them to Plaintiff while in Florida; however, his flight was delayed and he did not land in Fort Lauderdale until 2:00 a.m. on June 26, 2023, too late to contact Plaintiff. Per Mr. Johnson, he then shipped the awards back to Mr. Byrum before his flight back to Jamaica at 10:00 am on June 26, 2023.
- 12. On July 20, 2023, Mr. Grunwald testified that the plaques were found during a weekend video game event in Iowa. Plaintiff was not present at the event, but he called Plaintiff and that Plaintiff seemed surprised and excited the plaques found. Further, Plaintiff did not ask where or how the plaques were found. Mr. Grunwald also testified that he did not ask Mr. Johnson where he found the awards, but that he knew Mr. Johnson was going to the arcade and upon his return had the awards. Further, Mr. Grunwald testified that the original plan was for Mr. Johnson to travel to and from Iowa with Plaintiff as his layover from Jamaica was in Fort Lauderdale; however, Plaintiff was unable to attend the event and Mr. Grunwald simply assumed that Plaintiff got Mr. Johnson from the airport after the event, despite the multiple delays, as that was the original plan. See Defendant's Ex. 4, 18:13-19:19, 21:20-22:18, 28:5-29:15; 43:2-19.
- 13. Both Plaintiff and my office have diligently attempted to retrieve the plaques back from Mr. Byrum. However, Mr. Byrum is not cooperating at this time and noted that he has been harassed via text message by Defendant's counsel over multiple days starting on or about July 20, 2023 regarding the plaques, and despite Mr. Byrum's demands that Defendant's counsel stop harassing him. After Mr. Byrum demanded that Defendant's counsel stop, Defendant's counsel continued to text him and even went so far as to send Mr. Byrum a text stating that concealing evidence is a crime in California and sent him screenshots of the California Penal Code. On

- 14. Any assertion that I or my office purposefully misdirected or intentionally misrepresented information regarding the plaques or their location to Defendant's counsel is patently false. Despite efforts to obtain the plaques, Plaintiff has not been able to. Plaintiff does not have custody, control, or possession over the plaques to produce them for inspection.
- 15. On or about August 11, 2023, I had a call with David Bishop, the former executive vice-president and chief operating officer of NAMCO USA INC. Mr. Bishop detailed his history working with Namco, his relationship with Plaintiff, and his understanding of Plaintiff's relationship with Namco. Mr. Bishop reviewed and signed a declaration attesting that in 1999 Plaintiff was honored by Masaya Nakamura for his first perfect Pac-Man score and called him the "Player of the Century" and that this was how Plaintiff was described internally at Namco. Furthermore, Mr. Bishop stated that in or about 2015 Plaintiff was brought in to help market Namco's Pac-Man restaurant and bar, which had a framed picture of Plaintiff being honored by Mr. Nakamura in 1999. Mr. Bishop's declaration, dated August 16, 2023, is filed concurrently with this opposition.
- 16. Plaintiff's responses to Requests Nos. 251 and 293 included objections on the ground that production would violate the confidentiality of the settlement agreement, not just relevance as Defendant's Motion seems to argue. The settlement agreement between Plaintiff and Benjamin Smith has a confidentiality clause, which Plaintiff has advised Defendant of and Defendant provides no legal authority that would allow for the settlement agreement to be produced despite this confidentiality clause. Attached hereto as **Exhibit C** is a true and correct copy of the relevant portions of Plaintiff's deposition transcript. Plaintiff has been and remains willing to produce the agreement for in camera review.
- 17. Additionally, Defendant's counsel misrepresents Plaintiff's deposition testimony regarding the videos made by Benjamin Smith by claiming that Plaintiff testified that the videos made by Mr. Smith are in his possession. Plaintiff testified that he owned rights to the videos, not

that he actually had copies of the videos. See Plaintiff's Exhibit C.

- 18. Defendant's counsel also misrepresents the substance of Cross-Defendant Walter Day's testimony. Mr. Day testified as to his declaration related to Josh Ryan that the information in the declaration must have been the information he had at the time but he did not remember exactly during his deposition. See Defendant's Ex. 2, 92:23-95:7.
- 19. Mr. Day testified that the quoted language was the substance of what Jace Hall said to him and that is what he told Plaintiff's son in preparation of the declaration. Specifically, Mr. Day stated that the wording may have been different, "[b]ut the essence is the same" and that "it captured the exact essence of what had happened." See Defendant's Ex. 2, 154:4-158:3.
- 20. My billing rate in this matter is \$375.00 per hour. I have expended 19.5 hours in connection with opposing Defendant's motion. The total amount of monetary sanction sought is \$7,312.50.

I declare under penalty of perjury under the laws of the State of California that the foregoing is true and correct.
